The first day of class is May 16. The last week of class is the week of July 13, 2022 (including final exams). Consult the 2021-2022 Academic Calendar for more information. Registration for summer school 2022 begins on April 18, 2022 for all students and continues until the first day of classes. You do not need an alternate pin to register. For questions about externships, contact Ms. Ines. Note that your externship placement must be secured before applying to the Public Interest, Advanced Public Interest and Judicial Externship. You must similarly be approved for the ADR summer externship. Contact Ms. Ines and/or Prof. Woods regarding the ADR summer externship. **You must be registered for an externship class by May 11, 2022.** Students must be registered by the Records team at hustregister@gmail.com for all externships. Students, your professor will provide the approved student list to Records.

Note that summer classes may be cancelled for under enrollment. This determination will be made by early May.

Because of the condensed schedule, **there is no add/drop period**. If you are not registered by the first day of class, you cannot take summer school. Further, if you register for one class and want to drop that one class, you must complete a total withdrawal from the summer semester. If you complete this total withdrawal before the first day of class, the “W” for withdrawal will not show on your transcript. If you register for two classes and decide just to take one, you can drop that class before the first day of class. Be sure that you plan to remain in the course if you register and do not drop/withdraw by these timelines.

It is important that, if you fall below the academic probation minimum GPA of 75 after your Spring 2022 grades **are posted in June**, you may be ineligible for financial aid and will likely have to appeal your eligibility for aid through the SAP process. In this appeal, it is possible that you are ineligible for aid.

In June, the Registrar’s office may disenroll students from summer school. Note: students will only be disenrolled from their summer class(es) if they did not apply for aid and did not pay tuition independently—or—are ineligible to receive aid due to their lack of good standing (i.e., less than a 75 GPA after spring 2022 grades are posted). Students who are academically dismissed from the Law School (GPA below a 72) will also be disenrolled; will not receive summer school credit; and will owe any and all fees incurred (though they are likely ineligible to receive financial aid). **You are HIGHLY DISCOURAGED from signing up for a summer course if you were in the Academic Success Program or on academic probation as it is possible that, if you do not achieve good academic standing after all grades are posted in June 2022 (i.e., one month after summer school begins), you may face academic dismissal and you cannot receive credit for summer school. Further, you will be required to pay back any aid that you may have received for summer school.**

Note that summer school financial aid will be disbursed on May 6, but funds will not be available to you until the SAP has run and it is confirmed that you are in good academic standing and eligible for aid. For this reason, pay particular attention to the memo sent by Financial Aid on April 18, 2022. I have copied it below for your convenience.

Subject: Steps to apply for Financial Aid for Summer 2022

Dear Law Student,

Hope you are well. At a meeting held on Friday, April 1, 2022 with the School of Law and the Offices of Bursar and Financial Aid regarding summer 2022 Financial Aid, it was decided that law students seeking summer financial aid would do All of the following by the first day of summer classes:

1. Complete the summer loan application on the link below to Apply for summer aid. Per your Bisonweb Financial Aid Award tab for the 2021-2022 academic year, if you have received the maximum Federal Direct Unsubsidized loan of \$20,500 for the 2021-2022 academic year, you would need to apply for the Federal GradPlus loan only (by clicking on the link below). If per Bisonweb Financial Aid award tab, you did not receive the maximum Direct Unsubsidized loan of \$20,500, then you may apply for the difference on the link below.
2. Since your 2021-2022 GradPlus loan credit check has expired, you must log into www.studentaid.gov to Apply for the GradPlus loan for summer 2022 (loan period is May 2022- July 2022)
3. Once you are enrolled for at least half-time (4 or more credits) and your summer aid packaging has been finalized , the Office of Financial Aid will process your GradPlus loan that was approved for summer 2022 on www.studentaid.gov and have submitted the loan adjustment form on the link below (found on the HU website).


However, your summer aid would not be disbursed until all of your grades have been reported.

4. Because your grades would be outstanding at the beginning of classes, your Satisfactory Academic Progress (SAP) check (which is a federal financial aid requirement) would be Incomplete. Thus, Dean Olivares (HUSL Associate Dean) would provide the Office of Financial Aid with a list of law students who earned a GPA of at least 75 at the end of fall 2021 and are passing all courses for spring 2022. Students whose names are on the list and have applied for and are eligible for summer aid would be able to apply for a Short Emergency loan. The short-term emergency loan application and its loan terms will be provided by April 22, 2022.

5. The Short Term Emergency loan application amount cannot be greater than the amount of the summer aid approved by the Office of Financial Aid)

6. Once the SAP check is calculated for the law students in June, the pending aid would be disbursed, and The Bursar will retain the amount of the short-term emergency loan that the student had borrowed. Using this approach would ensure that the student repays the short-term emergency loan with their summer aid.

7. The School of Law shared at the meeting that law students at risk for not making satisfactory academic progress are advised to not enroll in summer school since you would not be eligible for financial aid. Please contact Dean Olivares if you have any academic related questions.
