- Review the Academic Calendar for important dates. You do not need an alternate pin to register. You will register using Bison Hub. For questions about externships, contact Ms. Bernice Ines, Assistant Director of the Clinical Law Center. Note that your externship placement must be secured before applying to the Public Interest, Advanced Public Interest and Judicial Externship. You must similarly be approved for the ADR summer externship. Contact Ms. Ines and/or Prof. Woods regarding the ADR summer externship. You must be registered for an externship class by Wednesday, May 7, 2025. Students must be registered for externships by the Records team at https://www.howard.edu. Students, your professor will provide the approved student list to Records. If you are approved for an independent study, send the approval email to https://www.howard.edu.
- Because of the condensed schedule, **there is no add/drop period**. If you are not registered by the first day of class, you cannot take summer school. *Note that we will confirm with the HU Registrar that the HUSL last day of add/drop is May 19. Further, if you register for one class and want to drop that one class, you must complete a total withdrawal from the summer semester. If you complete this total withdrawal before the first day of class, the "W" for withdrawal will not show on your transcript. If you

register for two classes and decide just to take one, you can drop that class **before the first day of class**. Be sure that you plan to remain in the course if you register and do not drop/withdraw by these timelines. If you miss the withdrawal deadline, you receive a failing grade on your transcript.

- It is important that, if you fall below the academic probation minimum GPA of 75 after your Spring 2025 grades <u>are posted in</u> <u>June</u>, you may be ineligible for financial aid and will likely have to appeal your eligibility for aid through the SAP process. In this appeal, it is possible that you are ineligible for aid.
- Students who are academically dismissed from the Law School in June 2025 cannot continue in summer school. In that case, the student will not receive summer school credit and will owe all fees incurred (and they are likely ineligible to receive financial aid). You are **HIGHLY DISCOURAGED** from registering for a summer course if you were in the Academic Success Program or below the minimum GPA required for retention as it is possible that, if you are below the GPA after all grades are posted in June 2025 (i.e., one month after summer school begins), you may face academic dismissal and you cannot receive credit for summer school. Also, if you are not enrolled for at least 4 or more credits for summer, the Office of Financial Aid cannot determine your eligibility for financial aid.
